

**CONDITIONS AND ADDITIONAL INFORMATION**

- \* The owner/agent of any dog loose on the coursing field will be fined \$5.00.
- \* Conformation judging will be outdoors with no cover, unbenched/unexamined.
- \* Coursing entries received after the closing date will be charged the late/day of trial fee.
- \* Stakes will be split if the entry reaches 24 or more at Roll Call.
- \* Dogs absent at Roll Call will be scratched and entry fee not refunded.
- \* Bitches in season and lame hounds will have their entry fees refunded, provided notice is given at, or before, the field trial roll call.
- \* Camping is NOT permitted on the grounds. Washrooms/concession available.
- \* Any exhibitor not cleaning up after their dog will be fined \$10.00.
- \* It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- \* Anyone exhibiting unsportsmanlike conduct will be asked to leave the trial site.

**DIRECTIONS TO THE COURSING/SHOW SITE:**

From Hwy #1 East take Exit #92 (Hwy #11 North to Mission). Follow signs to Mission. Exit off the bridge onto Hwy #7 East (signs indicate Mission City Centre/Agassiz/Harrison). Turn right at the light onto Hwy #7 East. Turn left onto Stave Lake Road. Turn right onto 5<sup>th</sup> Avenue and you will come directly to the parking lot.

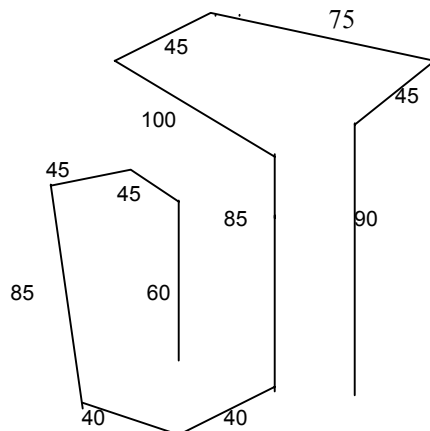

**ELIGIBLE ENTRY:**

**FIELD TRIAL** - For any Whippet that is one year of age or older on the date of the trial, registered with, or eligible for registration with, the Canadian Kennel Club. ERN/PEN dogs are eligible. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible.

**CONFORMATION SHOW** – For any Whippet, one year of age or older on the day of the show, except those with breed standard disqualifications, that has **earned a qualifying score** in the preceding lure course. Any dog excused, dismissed, disqualified, scratched, or not scored in the lure course is **not** eligible to compete in the conformation show.

**EQUIPMENT:**

Gas powered drag line lure machine with white plastic streamers.

**ROLL CALL:** Lure coursing roll call will be at **9:00 a.m.** Judging of the conformation show will commence shortly after the completion of the trial.

**CHAMPIONSHIP POINTS (LURE COURSING):**

Will be awarded as follows: 1st place - four times number competing to a maximum of 40 points; 2<sup>nd</sup> place - three times number competing to a maximum of 30 pts.; 3<sup>rd</sup> place - two times number competing to a maximum of 20 pts; 4<sup>th</sup> place - one times the number competing to a maximum of 10 points; NBQ - no points awarded.

**CHAMPIONS AND CHAMPIONSHIP POINTS (CONFORMATION):**

Section 20.2. A dog awarded WINNERS at a championship show held under these Dog Show rules shall be credited with a number of championship points (ranging from 0-5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder

**CLASSES AND STAKES OFFERED:**

**Lure Field Trial:**

- \* Open Stake – for all dogs, including Field Champions
- \* Kennel Stake – for any 2 entered dogs, owned and living with the same owner. Total of scores to determine winner
- \* Breeder Stake – for any 2 entered dogs, bred by the same person. Total of scores to determine winner

**Conformation Show:**

- + Canadian Bred – for dogs born in Canada
- + Bred By Exhibitor – for dogs owned and handled by the breeder
- + Open – for all dogs
- + Veterans – for all dogs age 7 and over, altered dogs may compete
- + Specials Only – for Canadian Champions only
- + Altered Open Male/Female – for all surgically neutered/spayed dogs. Points may not be carried over into these classes from the regular competition judging. Classes will be judged immediately following the Regular breed classes.

**NOTE – hounds must be pre-entered to compete in the Conformation Specialty Show and must compete in the Field Trial (see eligibility).**

**IMPORTANT NOTICE:**

**Effective July 1998, hounds entering their first trial in Canada must be tested with another dog and certified running clean by a licensed judge. The CKC Hound Certification form must be completed and submitted with their entry at the hound's first trial. Hounds with the following are exempt: ASFA F.Ch. or LCM, AKC F.Ch., S.C. or D.C. , but are still required to submit the Hound Certification form with their name and exempt title(s) circled.**

**NON CKC MEMBER PARTICIPATION FEE**

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. (\$57.60). In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. **These fees apply only to dogs wholly owned by Canadian non-CKC members and are not applicable to CKC members.**

**AWARDS:**

Rosettes will be offered for all coursing placements. Prizes and rosettes will be awarded to 1st in each stake, BOB, Kennel & Breeder Stake winners. Prizes will be awarded for High Score First Time Entered, Veteran, non-local, and "Hare to Party" in the coursing trial. LMWA will offer awards for BOB, BOS, BW, Winners, Reserve in the Regular Conformation Classes and BOB, Winners, and Reserve in the Altered Conformation Classes.

I (we) agree that the Club holding this show/field trial has the right to refuse entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of my (our) entry and of the holding of the event and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Lower Mainland Whippet Association, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which maybe be alleged to have been caused directly or indirectly to any person or thing by the act of the dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club of any of the parties aforementioned, or by the negligence of any other person, or any other cause of causes.

## EXTRACTS FROM CKC DOG SHOWS RULES

### Chapter 4.1.3 - JUDGES

A Judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

### Section 8.3.1 ENTRIES AND ENTRY FEES

Every dog entered in Championship Shows held under these Rules must be registered, or eligible for registration in the CKC. If a dog is not registered individually in the CKC, it may be entered in a show held under these rules as a "listed" dog, provided a) it is not a Miscellaneous breed, b) if born in Canada, is eligible for registration in the records of the CKC; c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained within 30 days of the first show entered. A listing fee of \$8.40 must accompany the entry of a "listed" dog at a show held under these rules.

### Section 8.6.2 DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

### CHAPTER 14 - DISQUALIFICATION

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action.

### CHAPTER 5 - EXHIBITORS AND THEIR DOGS

A show-giving Club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

## ADDITIONAL INFORMATION

Exhibitors are expected to know the Canadian Kennel Club Dog Show Rules.

All entries must be complete, signed and must be submitted on the current official CKC entry form (back side of form not required). Entries submitted in any other size or format will be rejected. Telephone entries are not accepted. Incomplete or conditional entries, entries received without full entry fees or valid credit card numbers, or entries received by the Show Secretary after the advertised closing date/time will not be accepted. There will be no refund on overpayment or duplicate entries. Please type or print legibly in black ink, especially when faxing. **It is recommended you phone after submitting entries via fax to ensure the transmission was complete and legible.**
